This "Group Tour Agreement", outlines the Museum's policies of Group Tours which are designed to help you prepare for a smooth check-in process. Please **READ, REVIEW, and INITIAL EACH STATEMENT** on the Group Tour Agreement indicating that you understand and will comply with each Flagler Museum policy concerning Group Tours. Please return this page to the Group Tour Coordinator prior to your arrival.

Please be advised: Groups must check-in as a group, at the scheduled time of arrival. The Museum does not offer bathroom facilities, water fountains, or seating to groups or individuals of groups, before check-in time. We recommend one representative check-in the group prior to disembarking from transportation.

Prior to Arrival:

1. _____ A Group Tour is not confirmed until the Flagler Museum has received the signed and initialed Group Tour Agreement.
2. _____ The group should arrive no earlier than 15 minutes prior to the scheduled tour time. No one from my group will be allowed entry prior to the group check-in.
3. _____ All the policies and procedures will be explained to the group's designated Group Escort and all members of the group.

- ☐ The group will be arriving by bus/van.
- Please park buses in the designated Bus/RV parking along the Visitor Parking Lot while the group is on tour. One Complimentary admission is available for the Bus Driver and must be redeemed at the time of check-in.
- ☐ The group will be arriving individually in private vehicles.
- Parking is free. Cars and vans may park in the Visitor Parking Lot.

Checking-In:

- 1._____ Upon arrival, the group must have a minimum of 20 visitors to qualify as a Group Tour. **If the group does not consist of at least 20 visitors, it is no longer eligible for the Group Tour rate and must pay the General Admission rate of \$28.00/Adult.**
- 2._____ The group escort must notify the Kiosk Attendant at the front gate of the Museum upon arrival. The Group Tour Coordinator will greet the group at the scheduled check-in time.
- 3._____ If the group arrives more than 15 minutes early, it must wait until the assigned check-in time to utilize restroom facilities, water fountains, or seating. Members of the group will not be permitted individual entry.
- 4._____ If the group arrives more than 15 minutes past the scheduled tour time, it will forfeit the Tour Docent. Audio Tours, the Flagler Museum App, and Self-Guided Brochures are available at no additional cost.

While Touring:

- 5._____ The reservation for a Group Tour is not a Private Tour. Members of the general public are always welcome to join the tour as well.
- 6._____ Please plan to spend at least 45 minutes on site, which is the minimum amount of time normally required for a Group Tour.
- 7._____ All visitors in the group will be expected to follow the Museum Policies listed below.
 - Water/liquids/food/gum, backpacks of any size, and strollers are not allowed in the Museum or on the Museum grounds. If you have questions about acceptable items, please ask in advance of your arrival
 - Flash photography is not permitted
 - Cell phones should be turned off or silenced
 - To protect the Museum and its collection, visitors may not lean on or touch the walls and furniture
 - All visitors must be respectful of fellow visitors, Docents, and Museum Staff
